Example Objective/Key Result Table

Quarter	Objective	Key Result
Q1, 2024	Increase Consortium Membership	Interview three ActivitySim users who are not Consortium members
Q2, 2024	Increase Consortium Membership	Conduct exit interview with any agency that leaves the Consortium
Q1, 2025	Increase Consortium Membership	Have 13 Consortium members
...
